8.5 Financial Procedures

Upon rotation of the Treasurer and the Group Chairperson, each person is to make sure that the incoming Coordinator gets signed onto the bank account and their own name is removed within 30 days. On-line account access will be changed every year with the election of the new Treasurer.

The only account that will have an ATM/Debit OR Credit Card will be the Refreshment Expense Account. No other accounts will be issued an ATM/Debit OR Credit Card.

All checks will require two-signatures. Those will be the Group Chairperson and the Group Treasurer only.

There will be an audit (2 times per year) of the SNL's financial books in July, when the New Group Chairperson takes over the position, and again in January when the New Treasurer and co-Treasurer take over their positions. This audit will take place at the Finance Committee meeting that is held in July and January. Upon completion of the Audit report it will be presented to the Group for review.
