STEERING COMMITTEE REPORTS

GROUP CHAIRPERSON: (John H.)

- Thanks to all who participated in getting the coffee area put together. This has been a great addition to our room and another opportunity for service for our members.
- Please keep in mind that this room is currently going through a change and alky's don't do change very well. However, this group voted for many of these changes several months ago and those individuals involved in the process when we gave approval are still working to get the room in order. Patience is a spiritual principal and certainly cooperation is as well. Please run your questions about changes through our Facilities Coordinator and our trusted servant, Phil, as they are the ones responsible for getting things done.
- Our basket income picked up a little in February but income remains an issue for our group.
 We need to be fully self supporting if we're to continue to stay here and carry the message of recovery the way SNL has always carried it: by showing newcomers that they can have fun in sobriety as well as provide a place to meet and have books to study from.
- I would encourage all members to dig deep when you can.
- I would encourage all Meeting Coordinators to work with your individual meeting secretaries to make sure that baskets are being passed properly and encourage a second passing if a number of people came in late. Again, even an extra \$5 per meeting will go a long way in buying books and providing for a good meeting place.....all part of our primary purpose.

GROUP SECRETARY: (Sheila D.)

TREASURER and CO-TREASURER: (Betsy and Fran)

- Income of \$5104.03
- Expenses of \$5,329.78
- Under budget -\$225.75
- Coffee donations went up a whole lot probably due to the new kiosk

FINANCE COORDINATOR: (Colleen....fill-in, Jennifer)

• Operating expenses went back up, hopefully our recent drop was a rare occurrence

- Literature went up. We're unsure why this was the case. Maybe secretaries are recording better on the envelopes or members are paying for books donated to newcomers. Either way, both are a positive moves for SNL's efforts towards being responsible members for the group.
- We did a 6 months audit through December
- Note to secretaries....we need to fill out each line item on envelopes completely as that effects accurate finance reports for the group as a whole. Reminder, we count and record money AFTER the meeting. Accurate recordings of each line item is a reason for that group request. Our records can only be as accurate as the figures received from our trusted servants in secretary and Steering Committee positions handling group money.
- Discussion
 - We looked at the February/March income reduction and they differ from this months income which has vastly improved. We're continuing to watch finances for trends while adhering to the IGCD.
 - There's worry of donation burn-out with members who regularly donate to our group
 - The bottom line is that we need to sustain a meeting place in order to have our group exist and carry the message. Sharing at meetings and providing literature are how we pass the message to the suffering alcoholic. These two things alone take a substantial budget.
 - Please understand, if you want changes, make a proposal to change the IGCD. We (Steering Committee members) are not leaders and do not govern how things are done, we are trusted servants. YOU, the group, make decisions and changes. We're simply adhering to the IGCD as it's written as a result of decisions made by YOU, the group. Desire to change anything needs to come from YOU, the group, through a proposal and voting. Otherwise, current actions on the part of the Finance Committee will and do follow what is outlined in the IGCD.
 - Events have provided us seed money but are not relied on for operating expenses
 - Consider passing the basket twice at meetings
 - Reminder that AA was founded in the era of the depression. The spirit of our SNL community has and can continue to support the fellowship we have today.

GENERAL SERVICE REPRESENTATIVE and ALTERNATE (GSR): (John C. and Jennifer)

- Proposed 3 questions to bring back to the GSR Conference
- Should the Grapevine be supported?
 - In a GSR review, 97% voted that the Grapevine is important to have but only 3% have a subscription. Members are not showing support through subscriptions.
 - Member opinion, "No! GSR has enough "#*/@!*" to worry about w/o the Grapevine added on to it."
- Should the Preamble be added to the front cover of the Big Book?
 - Vote results: 17 yes, 6 no
- Should AA be on Facebook for carrying the message?
 - Strong No from the group

INTERGROUP REPRESENTATIVE and ALTERNATE (IRG): (Sarah)

- Flyers will be posted in the back for upcoming events
- Traditions workshop in Gilroy on June 16th
- Central Office wants us to reach out to all meetings to share about Intergroup

<u>PUBLIC INFORMATION/COOPERATION WITH THE PROFESSIONAL</u> <u>COMMUNITY COORDINATOR (PI/CPC):</u> (Ramon)

- Purpose of group was read....
- We recently had a presentation in a room of 50-60 Spanish speaking kids where the question was asked of the group to raise their hands if there's a problem with alcohol in their relationships. Almost all hands were raised. That's what PI/CPC does, we bring the message to large groups who have been or are effected by this disease.
- We're hoping to get younger members involved. This is prom time.
- Really glad to be elected, had no idea of all of the service opportunities happening
- We can reach out anywhere an idea is planted so if you have an idea tell us and we can create something. Any community; gays, music communities, elderly, athletics, and on and on.....the opportunities are limitless.

- Since not a lot of people show up on Birthday night, we're putting a column on the birthday board to indicate if you'll be here to receive your chip. April will be our first month to try this.
- A member expressed concern with skipping the announcement of names not present on Birthday night. Reason being, it's nice to hear the names and the number of years of sobriety. It's very encouraging for members, new and old, to hear what kind of sobriety is possible in our SNL group of Alcoholics Anonymous.

REFRESHMENTS COORDINATOR: (Tim D.)

- The new coffee kiosk seems to a big success
- Thank you to members who have stepped up to volunteer as coffee servers
- We've seen an increase in coffee and supply
- The coffee donation basket increase is fantastic, however, that money goes to the group income
- We ran out of money too early this month and appreciate the donations of a few members
- We had donations of \$114 in paper supplies, \$76 for coffee, and \$27 in coffee and cleaning supplies. The total in donations was \$217

- A Request was made to secretaries, meeting coordinators, and all SNL members to please help the group by ensuring we aren't wasting coffee and other supplies like trash bags, hand towels, and cups.
- It's hoped that we can control waste and have enough supplies without having to ask members to donate.
- We are losing TP to theft, it's recommended to not put extra rolls out.

- St. Patrick's Day was fully funded through donations and brought in \$300
- The April 21st Tile-Pizza Party will be fully funded with donations from members
- A member would like "Day on the Gravel" to come back
- It takes about 2-3 months to plan an event
- Proposal to change the May 12th Business Meeting to May 19th since the only date available for the "Thank You" picnic was on May 12th.
